CITY OF LOGANILLE Council Meeting Tuesday, February 18, 2014 6:30pm Council Chambers

The City of Loganville Mayor and Council met for their regularly scheduled Council Meeting on Tuesday, February 18, 2014 at 6:30pm in the Council Chambers. (The regular Council Meeting that should have been held on February 13th was rescheduled to this date due to inclement weather.) Mayor Dan Curry and Council Members Chuck Bagley, Skip Baliles, Jay Boland, Mike Jones, Mark Kiddoo and Rey Martinez were present.

Mayor Dan Curry called the meeting to order at 6:30pm.

Loganville Baptist Church Pastor Rusty Ruark gave the invocation and the pledge to the flag was led.

Council Member Mark Kiddoo made a motion to amend the agenda to include the reconfirmation of the Vice Mayor's election. Council Member Skip Baliles seconded the motion. Motion carried 6-0.

Council Member Rey Martinez made a motion to approve last month's minutes as presented. Council Member Chuck Bagley seconded the motion. Motion carried 6-0.

Council Member Mark Kiddoo made a motion to approve last month's financial report as presented. Council Member Rey Martinez seconded the motion. Motion carried 6-0.

Mayor Dan Curry gave the Oath of Office to newly appointed members of the Planning Commission: Linda Dodd, Danny Ford, Barbara Forrester and Janice Tribble.

Council Member Chuck Bagley nominated Mark Kiddoo as Vice Mayor. Council Member Mike Jones made a motion to close nominations. Council Member Chuck Bagley seconded the motion. Motion carried 5-1 with Mark Kiddoo abstaining.

Council Member Rey Martinez made a motion to purchase turnout gear for the Fire Department for \$18,312.00. Council Member Mark Kiddoo seconded the motion. Motion carried 6-0.

Council Member Jay Boland made a motion to approve the 2014 Fox Chase CDBG for \$425,417 and approve McFarland / Dyer to do the engineering work for the project. Council Member Skip Baliles seconded the motion. Motion carried 6-0.

Council Member Jay Boland made a motion to approve changes to the water and sewer ordinance in order to reflect current policies. Council Member Chuck Bagley seconded the motion. Motion carried 6-0.

City Manager Bill Jones presented the revision to the Alcohol Ordinance to reflect the Gwinnett County Judge's order regarding Dwight Harrison's appeal. Council Member Mark Kiddoo made a motion to approve the amendment as presented. Council Member Mike Jones seconded the motion. Motion carried 6-0.

City Attorney Robyn Webb presented the resolution regarding the LDA to the Mayor and Council regarding appointments to the Authority. Council Member Mike Jones made a motion to approve the resolution as presented. Council Member Skip Baliles seconded the motion. Motion carried 6-0.

With no further business, Council Member Mark Kiddoo made a motion to adjourn. Council Member Chuck Bagley seconded the motion. Motion carried 6-0.
