CITY OF LOGANVILLE Regular Council Meeting Minutes Thursday, March 10, 2022 6:30pm Council Chambers

The Mayor and Council for the City of Loganville met for their regularly scheduled Council Meeting on Thursday, March 10, 2022 at 6:30pm in the Council Chambers. Mayor Skip Baliles and Council Members Linda Dodd, Bill DuVall, Anne Huntsinger, Melanie Long and Branden Whitfield were all present. Council Member Jay Boland was unable to attend.

Mayor Skip Baliles called the meeting to order at 6:30pm.

Pastor Calvin Mapp with Morning Star Baptist Church gave the invocation and the pledge to the flag was led.

Mayor Skip Baliles recognized Braxton Roberts and his son for work on their business downtown and their efforts to bring business to downtown.

Council Member Bill DuVall made a motion to remove the Mural Ordinance from the agenda and approve the agenda with that revision. Council Member Anne Huntsinger seconded the motion. Motion carried 5-0.

Council Member Melanie Long seconded the motion. Motion carried 5-0.


