CITY OF LOGANVILLE Regular Council Meeting Minutes Thursday, January 13, 2022 6:30pm Council Chambers

The Mayor and City Council for the City of Loganville met on Thursday, January 13, 2022 at 6:30pm in the Council Chambers. Mayor Rey Martinez and Council Members Jay Boland, Linda Dodd, Bill DuVall, Danny Ford, Anne Huntsinger and Lisa Newberry were all present.

Mayor Rey Martinez called the meeting to order at 6:30pm.

Pastor Jimmy Williams from FBC Loganville gave in invocation and the pledge to the flag was led by Boy Scouts from Pack 536.

Council Member Danny Ford made a motion to approve the agenda as presented. Council Member Anne Huntsinger seconded the motion. Motion carried 6-0.

Council Member Linda Dodd made a motion to approve the Consent Agenda as follows:

Council Member Lisa Newberry seconded the motion. Motion carried 6-0.

Assistant Police Chief Dick Lowry introduced Officer Andrew Henry who recently graduated from the Police Academy.

Council Member Anne Huntsinger made a motion to give the Mayor the authority to sign the contract between TBDP, LLC allowing for the filming of a project in downtown and fee agreement providing the Certificate of Liability Insurance is acceptable. Council Member Danny Ford seconded the motion. Motion carried 6-0.

Council Member Anne Huntsinger noted for the record that in regards to the Waste Management rate increase that was discussed last month that the City will be allowing for a 4% increase now and the additional 2% once they have completed the requested training and changes as requested.

Council Member Anne Huntsinger made a motion to approve the City send a letter of support to the DOT in favor of the project to be filmed downtown. Council Member Danny Ford seconded the motion. Motion carried 6-0.

City Manager Danny Roberts presented outgoing Mayor Rey Martinez and Council Members Danny Ford and Lisa Newberry with plaques recognizing their service to the City.

Council Member Linda Dodd made a motion to adjourn old business. Council Member Lisa Newberry seconded the motion. Motion carried 6-0.

At this time, the Oath of Office was given to Mayor Skip Baliles and Council Members Anne Huntsinger, Melanie Long and Branden Whitfield.

Mayor Skip Baliles announced that the City Council would hold a retreat on February 5, 2022.


Council Member Linda Dodd made a motion to amend the agenda to include the discussion of the City Managers role in downtown development and filling positions on various committees. Council Member Bill DuVall seconded the motion. Motion carried 6-0.


